Social-Distancing and Hygiene Guidelines:

- Kids Summer camp 2020 takes place in Choplet Studio’s garden. Tables and wheels are spaced out to provide social distancing. There is a roof-covered area in case of rain.

- Kids and Staff are required to wear a mask over their nose and mouth at all time except during snack times. During snack break, kids will be strictly adhering to 6 feet distance between each other and will remain in the garden.

- Our outdoor studio is equipped with a sink. Kids will be instructed to clean their hands and forearms with soap upon arrival, before and after consuming food, when having used the restroom, and at the end of the day.

- Each kid must bring their own tool kit and apron daily. If they do not have one, please order them on the tool kit and clay for sale page on Choplet website, no later than 48 hours before the start of camp.

- All kid campers should limit the number of outside belongings being brought to camp to sunscreen, mosquitoes repellent spray, lunch box, mask and any necessary allergic equipment
